Applications will be reviewed by the Membership Director and the applicant will then be notified of the time and date to bring their artwork for final jury. Following the jury meeting, applicants will be notified of their acceptance or non-acceptance.

PLEASE NOTE: Member artists must live within 75 miles of River Art Gallery. Also, before submitting the application for membership in the River Art Group, please understand that we are a working art group. We depend on the active and ongoing participation of our members to operate our organization and our gallery. The gallery is located downtown in La Villita Historic Arts Village and sells primarily to tourists. Acceptance into RAG means you will be required to work a regular monthly schedule in our gallery. This means greeting customers, answering their questions, writing receipts for sales, handling money or credit cards, and wrapping merchandise, as well as helping keep the gallery neat. You will be a representative for River Art Group. Therefore, we are looking specifically for new members who will work cheerfully in a sales and business environment.
