The River Art Group, in cooperation with the LaVillita Historic Arts Village, presents **River Artober**. **River Artober** affords the River Art Group members and local artists an opportunity to showcase and sell their handmade art while bringing visitors to LaVillita Village.

Rules for Participation:

- **RAG Member Fee:** Free for yard, porch & other. All sales go through gallery.
- 10 x 10 booth space, for 2 days, \$50. (Sales run through Gallery-25% commission)
- 10 x 10 booth space for 2 days, \$100. (Member responsible for the collection and remittance of necessary sales taxes per artists 'vendor license. The River Art Group and the La Villita Association take no responsibility for the collection and remittance of sales tax. No commission to gallery.
- All fees Due with Application to reserve space.
  - River Art Group Members discount upon agreement to assist in show volunteer positions, such as Vendor Check-in, Booth Designation, traffic control helper in Set-up and Take-down, etc.)
- All vendors will be able to drive in to unload on Villita Street.
- Overnight security will be provided. (Not suggested for merchandise, but for Set-Up)
- Booths MUST be weighted down. (20 lbs. weight on each leg of tent.)
- Display set up is the responsibility of the artist, including table and tablecloth.
- There is no electricity available.
- Set up Friday, 7-9 pm or Saturday, 7-9 am.
  - Prefer RAG members to unload vehicles car on Friday night.
  - (More information will be provided upon acceptance and booth assignment)
- · Items for sale must be created by the submitting artist.
- Artists must be present during the festival.
- Artist assumes responsibility for tent/booth and its contents.
- Application Deadline August 1<sup>st</sup>, or until full.
- No verbal contracts will be made, Members must fill out Application with payment to secure spot.
