The River Art Group, in cooperation with the LaVillita Historic Arts Village, presents **River Artober**. **River Artober** affords the River Art Group members and local artists an opportunity to showcase and sell their handmade art while bringing visitors to LaVillita Village. This is a Juried Show, so non-River Art Group applicants must send photos when applying.*

Rules for Participation:

- **10 x 10 booth space for 2 days, \$125.-**
- **10 x 20 booth space for 2 days, \$200.-** (limited spaces available)
- *Works from non-River Art Group members **will be juried from photos enclosed with application. Please send 3, good quality images.**
- All fees Due with Application to reserve space. (Fees will not be taken if applicant does not qualify)

- Set up – Friday, 7-9 pm or Saturday, 7-9 am.
- All vendors will be able to drive in to unload on Villita Street, **before 9 am** Saturday.
- Overnight security will be provided. (Not suggested for merchandise, but for Set-Up)
- Booths **MUST** be weighted down. (20 lbs. weight on each leg of tent.)
- There is no electricity available.
- Display set-up is the responsibility of the artist, including tent, table, chair, tablecloth, etc.
(More information will be provided upon acceptance and booth assignment)

- Items for sale must be **created** by the submitting artist.
- Artists must be present during the festival.
- Artist assumes responsibility for tent/booth and its contents.
- **Application Deadline August 1st**, or until full.
- No verbal contracts will be made. Applications with payment will secure spot.
