

# River Art Group New Member Application

Membership in the River Art Group involves a juried application process. Applications may be submitted at any time throughout the year by an online process or by mail. Submitted work must have been produced within the past year. **The applicant must submit three images (photos, tiff or jpeg) as examples of their artwork for consideration.** Applicants may request consideration for acceptance in up to three different media (each medium will require three separate images). The jury will score the body of work presented based upon appeal, marketability, technical skills, originality, composition/quality. If the applicant achieves a minimum score of 75% (of a possible 100%), the application advances and the applicant will be notified of the time and date to bring their original artwork (must be the same as the work in the images submitted) for final jury review. Applicants will be notified of their acceptance or non-acceptance within 5 days of the final jury.

PLEASE NOTE: **Member artists must live within 75 miles of River Art Gallery.** Before submitting the application for membership in the River Art Group, please understand that we are a working art group. We depend on the active and ongoing participation of our members to operate our organization and our gallery. The gallery is located downtown in La Villita Historic Arts Village and sells primarily to tourists. Acceptance into River Art Group means you will be required to work a regular monthly schedule in our Gallery. This means greeting customers, answering their questions, writing receipts for sales, handling money or credit cards, and wrapping merchandise, as well as helping to keep the Gallery neat. You will be a representative for River Art Group. Therefore, we are looking specifically for new members who will work cheerfully in a sales and business environment.

Please place a checkmark on the days you are available to work and we will do our best to accommodate you. NOTE: If weekends are the only time that you can work this may not be possible.

Please DO NOT submit cash.**

  - d. Learn all the positions in the Gallery, including handling money, opening and closing the register and the Gallery. \_\_\_\_\_
  - e. Follow the Gallery Exhibit Criteria as described in the Art Gallery Rules when hanging my art work. \_\_\_\_\_

  - g. Refrain from using cell phone/tablet, etc. when customers are present in the Gallery. \_\_\_\_\_
  - h. I authorize photos to be taken of my art work which will be used as a basis of comparison during my provisional status. \_\_\_\_\_

- i. I will be evaluated at the end of 12 months. Upon receipt of a satisfactory rating, I will be allowed to continue for an additional 12 months and, at the completion of 24 months of satisfactory service, I will be notified of acceptance as an active member. \_\_\_\_\_
